Thrift Shop Achievements

- Mass renovation of shop- significant increase of Dollar branding and affiliation to the school
- £10,000 already set aside to fund school projects- audio system and floodlights. Since 2017 we will have donated over £23k to the school for various projects. Over £6k still available for donations from 22/23
- Continued digitalisation of payments and processing system
- 3 DofE award volunteers from the school helping with the running of the Thrift Shop
- Increased Footfall within the shop
- Introduction of drop-off points within the school- increasing the access parents and pupils have to the Thrift Shop
- Larger volunteer force than previous years
- Updated webpage on the school website
- Donation of old style Dollar branded coats to school in Glasgow in area of high deprivation
- Donation of old stock and unsellable stock to charity
